Ingredients: Hass avocado, fresh tomato, fresh onion, Jalapeño puree, salt, fresh serrano pepper, lime juice, dehydrated cilantro, xanthan gum and garlic.

Product Description: This product is seasoned chunky avocado pulp with ingredients, vacuum packed in plastic containers with EVOH barrier.

Process Description: The product is prepared under GMP's, Facility is FDA registered and BRC certified. The avocado is sorted, washed, ripened, disinfected, stem removed, peeled, seed removed, mixed with ingredients, vacuum packed, pressurized, passed through metal detection, and frozen.
